Determination of 17.1.2002

ALTERATIONS TO BE INTRODUCED IN THE PRICES OF THE SHARED ACCESS SERVICE PROVIDED WITHIN THE FRAMEWORK OF THE RUO

Upon determination of 28/06/01, PT Comunicações, S.A. was requested to provide, within 60 days, a duly justified price proposal for the Shared Access Service (in compliance with that indicated in point 10.a of the "Set of items to be included in the RUO").

Having analysed the price proposal presented by PT Comunicações, S.A., on 24/09/01, it was concluded to be necessary to review the prices presented, in light of the principle of cost orientation. In the process of estimating costs, it was decided to adopt a shared costs approach for the common elements (FTS and Broadband), although consideration was also made of the incurred costs approach, adopted by some regulators. The latter option was set aside because it was considered to still lack firm foundations, making it advisable to analyse possible evolutions that may occur, including those taking place at the European level.

Thus, after conclusion of the period of prior hearing of interested parties in compliance with the Administrative Procedure Code, ANACOM's Board of Directors, under the terms of paragraph a) of nr. 2 and nr. 3 of article 4 of Regulation (EC) no. 2887/00 of the European Parliament and Council, decided, in a regular meeting on 17/01/2002, to alter the prices of the shared access service provided within the framework of the RUO 2001, which should be integrated within the reference offer within a maximum of 5 days:
