ABOUT ITSO

Since the restructuring of the International Telecommunications Satellite Organization (ITSO) in 2001, the international telecommunications satellite environment has undergone significant changes. The regulatory environment has changed, new financial models have appeared, technology continues to evolve and of course, competition is now generally accepted in the telecommunications field in general.

All of these changes have also impacted Intelsat, which was established as a private company in 2001. One of the most significant changes affecting Intelsat relates to its financial structure. Gone are the old "signatories", which were in many cases government departments and/or public telecommunications operators and generally run by governments and publicly funded. Intelsat is now owned by private equity funds. This process has presented ITSO with new challenges and has underlined the need for a strong organization capable of ensuring that the objectives of the restructuring are fully met.

By its ability to provide global coverage and connectivity, satellite technology is ideally suited to ensure the continued development of a global information and communications infrastructure and to present key development opportunities to countries around the world through a reliable information and communication infrastructure. It is vital that all countries are able to obtain such connectivity so that the global society can effectively bridge the current divide between developed and developing countries and regions.

Against this background and within the limits of its mission as defined in the Agreement, it is essential that ITSO has a strong and experienced leadership which allows it to effectively contribute to the emergence and promotion of a global broadband communications infrastructure and to continue to discharge its obligations of:

- Supervising the performance by Intelsat of the Core Principles;
- Ensuring the availability in the long run and on a global basis of high-quality, affordable international public telecommunications services.
