## **POSTAL SERVICES**

#### PREVIOUS NOTES:

1) Due to updates to data sent by certain providers, corrections have been made to the figures given for traffic and the postal network since the beginning of 2008.

2) Due to the fact that certain operators failed to send statistical information on time, the information from these providers was not considered in the present report. It is estimated that the weighting of these operators, in terms of the various indicators given, is less than 1 per cent of the total.

The information below concerns postal services whose operation is liberalised. Postal services operated in competition are considered to be those encompassing mailed correspondence whose price exceeds 2.5 times the reference tariff (Priority Mail up to 20 grams) and weighing more than 50 grams. Reserved services are therefore excluded.

#### **1. Postal Service Providers**

Postal services operated in competition are provided conditional to the operator being granted an authorisation or licence<sup>1</sup>.

During the fourth quarter of 2008 (4Q08), ICP-ANACOM did not grant any new legal authorisations<sup>2</sup> for the provision of non-reserved postal services outside the scope of the universal service, whereas the authorisation previously granted to one undertaking was repealed.

Accordingly, there are now 61 operators holding authorisation to provide express mail postal services as at the end of 4Q08<sup>3</sup> (*See* Table 1).

In respect of services not covered by the express mail category, no new operators were granted licensing during 4Q08, and therefore the total number of licensed providers remained at 11<sup>4</sup>. One of these operators is the Universal Postal Service concessionaire (CTT) which operates according to the respective Concession Contract.

It should be noted that while *CTTexpresso* is legally qualified to simultaneously provide express mail services and services not covered by the express mail category, it continues to exclusively offer express mail services.

### 2. Traffic of postal services operated in competition

During 4Q08, traffic from postal services operated in competition totalled 71.6 million items, representing 23 per cent of the quarter's total postal traffic.

Traffic in liberalised services increased by 16 per cent over the previous quarter, while falling by 7.4 per cent compared to the same quarter of 2007.

There is typically an increase in the last quarter of the year due to the Christmas period.

### a) Postal traffic operated in competition - by destination

During the quarter being reported, the volume of *national* postal traffic totalled around 66.9 million objects, while *outgoing international* traffic registered 4.7 million objects (*See* Table 2). *National* traffic made up 93 per cent of total postal traffic operated in competition, with *outgoing international traffic* representing 7 per cent.

National traffic, which rose by 17.3 per cent over the previous quarter, was the main contributor to the rise in postal traffic seen in the quarter. The increase in national traffic is explained by trends in editorial mail, addressed publicity and addressed correspondence of the CTT group. Meanwhile, international outgoing traffic fell by 1.3 per cent, impacted by the downward trend seen for editorial mail of providers covered by the express mail category.




Compared to the same quarter of 2007, traffic fell by 7.4 per cent due, above all, to the fall seen in national and international correspondence and addressed publicity of CTT.

In the liberalised area, Grupo CTT was responsible for around 92 per cent of national traffic and for around 83 per cent of outgoing international traffic (See Table 3 and Graph 1).

## b) Postal traffic operated in competition - by service

During this period, 5.5 million of the total 71.6 million liberalised postal objects fell within the express mail category, with around 66 million being encompassed by the remaining service categories (See Table 4). Express mail therefore accounted for around 8 per cent of total traffic operated in competition, with the remaining categories making up 92 per cent.

As can be seen, the traffic of services covered by the express mail category grew by 14.3 per cent compared to 3Q08 and by 10.6 per cent compared to the same quarter of 2007. This increase is, above all, as a result of the trend in national parcels (See Table 4).

Non-express services grew significantly over the quarter but fell in year-on-year terms, due to the reasons behind the quarterly increase and annual fall in postal traffic given in the previous section.


In terms of the offer structure, it can be seen that in 4Q08 the companies of Grupo CTT retained a share of 44.5 per cent of express mail traffic and 95.6 per cent of non-express mail traffic (See Table 5 and Graph 2).

## c) Postal items per capita (liberalised services)

Table 6 shows the *postal items per capita* index. In 4Q08, this indicator stood at 6.7 postal objects distributed per inhabitant, of which 6.3 correspond to national postal services.

#### 3. Postal network indicators

Below some indicators are given from the postal network, in the areas of human resources, material resources and postal coverage and density:

#### a) Human resources

As at the end of 4Q08 there were over 16.4 thousand people working in liberalised postal services, 807 less than in the previous quarter (See Table 7). This quarterly change is directly affected by changes in the indicators for Grupo CTT, where the number of staff on fixed term contracts customarily spikes during the second and third quarters of each year as a result of the holiday periods.

#### a) Material resources, postal coverage and density

In final quarter of 2008 there was a considerable reduction in the number of access points (See Table 8), due to figures given by Grupo CTT. This essentially reflects a reduction in the number of post boxes in rural areas. As a result, postal coverage fell to an average of 20 access points per 100 Km<sup>2</sup> (See Table 9).

As a consequence the *postal density* index rose in 4Q08 to at an average of 574 inhabitants per available access point (*See* Table 10), giving a reduction in postal density.
